

 **READ THIS FIRST**

For quick processing of your account application, make sure the following steps are completed correctly by both accounts holders. This should help prevent any delays throughout the procedure of opening your account.

- ▶ Make sure that you fill out this application, preferably by typing. Make sure all data is complete, accurate, clear and readable.
- ▶ Print out the application pages (Pages 1, 2, 3, 4, 5, 6, 7, & 8) and sign in all the designated signature areas. The signature for both accounts holders is required on all pages of this Application.
- ▶ According to Anti-Money Laundering Laws and regulations, FxPulp is required to obtain certain documentation from you. This list contains the required documents, and we might request more documentation to satisfy the due diligence process at any time.

For **both accounts holders**, enclose the following documents:

① PROOF OF IDENTITY

A notarized true copy of a valid ID card or a passport document (with photo and signature) certified by a public notary, consulate or embassy. The notarization must have been made less than three months of the receipt date by FxPulp;

② PROOF OF ADDRESS

A recent utility bill such as electricity, phone bill, etc... or any other official proof of address. This document must be less than three months old.

Part 8 Declaration & Acknowledgment

Both Accounts Holder (herein The “Client”) hereby declares, ratifies, understands that:

- ▶ The Client has carefully considered the financial risk involved in trading Contracts for Difference, and is willing to assume such risks associated with this type of investment, and wish to proceed with opening an account.
- ▶ This application shall constitute an effective part of the trading agreement (hereinafter the “Agreement”) between Pulp International Business Limited “FxPulp”; and the Client upon acceptance and execution by an authorized officer of FxPulp, and shall apply to all dealings between FxPulp and the Client henceforth.
- ▶ This application, including all Annexes within, including annexes published on the website constitutes the entire agreement among the parties hereto and supersedes any and all prior agreements or understandings among the parties with respect to the subject matter hereof.
- ▶ The information contained in this application is true and accurate, that the signature(s) is/ are genuine and that any photocopies, including copies of the verification of identity documents forwarded are identical with the corresponding originals. The client is obligated to inform FxPulp immediately in case of any changes.
- ▶ The Client is of legal age and is legally competent to execute this agreement.
- ▶ The Client has prior experience trading in volatile markets.
- ▶ Should any, part, or all of the information and/or any ancillary documents provided in the application and the Agreement by the Client be false, incorrect, inaccurate or unlawful, this Agreement and all contracts within this Agreement may be considered null, void and cancelled at FxPulp own and absolute discretion. In the case of the cancellation of agreement FxPulp will not, in any case or manner whatsoever, be liable for more than the initial bank cash deposits less of that any losses or charges incurred on the account.
- ▶ FxPulp may, in the manner it deems appropriate, close out Client’s open positions in whole or in part, sell any or all of Client’s property held by FxPulp, buy any securities, Financial Instruments, or other property for Client’s trading account(s), and may cancel any outstanding orders and commitments made by FxPulp on behalf of Client without prior notice in the event the client failed to timely settle his/ her financial obligation such as credit facilities, maintain margin, and any other payment obligation.
- ▶ All transactions with FxPulp affected prior to the date of this Agreement, and that the rights and obligations of Client in respect thereto shall be governed by the terms of this Agreement. This Agreement may only be assigned by Client with the prior written consent of FxPulp. FxPulp is entitled to assign this Agreement including all authorizations, to its successors and assigns, whether by merger, consolidation or otherwise in its sole and absolute discretion without obtaining the consent of Client. This Agreement shall be binding upon and inure to the benefit of FxPulp and its successors and assigns, and Client's personal representatives and permitted successors and assigns.
